20.15 Apologies

20.25 Environment and Highways

1. Grindle House Farm

Cllr John Webb, in the Chair, reported that the enforcement date was 30th September and that Renew would be exiting at this time. There was to be no leeway in this matter. He had spoken to Graeme Manton of Apley Estates regarding this matter.

There was some discussion on the enforcement issue. Cllr Sarah Williams offered to write a letter to Shropshire Council asking for disclosure of information on the conversation between Apley Estate and Shropshire Council. She would also draft a letter to Shropshire Councillor Michael Wood. There was agreement by the Council on this as a way forward.

2. Vandalism of Memorial Benches

There was some discussion on the quotes that had been obtained for the replacement bench and the most suitable material. Cllr John Webb said that for a small parish with a small budget, metal was an expensive outlay. Wood is more comfortable, and the value in scrap metal is an enticement for theft. Cllr Sarah Williams said she preferred the aesthetic of wood but was concerned about the vandalism potential. Cllr Neil Dodd suggested looking at composite plastic as an alternative.

It was agreed that the Clerk should investigate the alternative of composite plastic, and that findings are to be put in a chart for Councillors to consider the options available.

3. Other Environment and Highways Matters

It was agreed that the Parish Clerk should draft a letter to the Head of Highways on behalf of the Parish Council, commenting on the quality of recent road works.

The following issues were raised and are to be included:-

- Passing places have not been dressed so there are huge crates in lay-bys
- Dressing has gone onto the road without surfacing the road underneath
- The work that has been done is of poor quality
- There is subsidence on the road between Ryton and Beckbury

Cllr John Webb, in the Chair, reported that he had spoken to the managers of PDM about the proximity of vehicles to a telegraph pole on the Caynton Lane. The telegraph pole had been replaced by Open Reach in November 2019 after it was knocked down by PDM vehicles.

It was agreed that the Clerk and Chairman would draft a follow up letter further to this conversation.

20.26 Neighbourhood Plan

Cllr Richard Holt reported that a flyer had been produced and was ready to be collected and distributed. He said that he would distribute it in Ryton. Cllr Neil Dodd offered to deliver it in Grindle.

Cllr Sarah Williams expressed concern at the time it had taken to get the process running. There was discussion about the process and requirements, and on encouraging people willing to form a sub-committee.

Cllr Richard Holt said that the new Government policy on the planning process had made him question if the Neighbourhood Plan format was still the correct procedure to underpin the planning process. Is this the mechanism? It was agreed to investigate this further.

20.27 Correspondence

On 24th January, the Chairman had sent a joint letter with the Chairman of Kemberton Parish Council to the C.E.O of Shropshire and Phillip Dunne M.P about the condition of the roads. The C.E.O of Shropshire had left soon after. There was some discussion about the lack of response from Shropshire Council. Phillip Dunne had, however, responded and had visited the Parish recently to discuss the matter with the Parish Council.

20.28 Other Parish Matters

Cllr Sarah Williams commented that, ‘the squeakiest wheel gets oiled’ and that more use should be made of Fix My Street for reportage of plot holes, fly-tipping and other issues that are the responsibility of Shropshire Council. It was suggested that reference to this should be included in the Parish Magazine as well as on the Parish Council’s website.

Cllr Richard Holt suggested that the two triangles areas bee seeded as a wildflower meadow and strimmed once a year. There was general agreement that this was a good idea, Cllr Sarah Williams added that for highways visibility strips might need to be mown adjacent to the road. It was agreed that this suggestion should be put in the spec for maintenance in February.
